

OWNER'S ENGINEER'S SERVICES FOR 1124 MW KOHALA HYDROPOWER PROJECT



1124 MW Kohala Hydropower Project (the "Project") is located on Jhelum River at about 35 km away from Muzaffarabad and 85 km away from Islamabad. The development of the Project is being undertaken by the KOHALA HYDRO COMPANY (PRIVATE) LIMITED (Owner, KHCL in abbreviation), of which the major shareholder is China Three Gorges South Asia Investment Limited (CSAIL), which is a subsidiary of China Three Gorges Corporation (CTG), on Build-Operate-Own-Transfer (BOOT) basis.

The Owner invites proposals from potential Owner's Engineers to provide the consulting services as Owner's Engineer for the Project (the "Services") during Project Development Period, Construction Period and Defects Notification Period. More details on the Services are provided in the Terms of Reference in RFP.

The Invitation to Tender is open to any tenderer (including all members of a Consortium) who meets the requirements of relevant experience and financial standing as specified in the Bidding Documents, among which a crucial eligibility requirement is that the Owner's Engineer contract shall be awarded to a Joint Venture constituted by at least two companies specified as follow:

1 One of the companies will be a non-Chinese well-known international Owner's Engineer company with ranking within TOP 100 on ENR's 225 International Design Firm List for 2015 and 2014; and this company shall be the Lead Partner

2 The other one of the companies will be a company with Chinese A-grade engineering design & Chinese A-grade construction supervision certificate in hydropower project

The participating companies can obtain the bidding documents by adopting the following ways:
